This means a secondary producer can demonstrate that two-thirds of its fiber supply comes from suppliers certified to the procurement objectives (*SFI 2005-2009, Objectives 8-13 or SFI 2010-2014, Objectives 8-20*) and the other one-third cannot come from controversial sources.
